Mr. Bird reported on a School Safety Grant that the District applied for. This Grant would pay for a film put on the entry door and windows, locks for all inside doors and some phone changes that would go directly to county sheriff dispatch with a push of a button. He also said the District is applying for a Grant to help with the cost of replacing all lighting with LED lighting. If we get the Grant the cost to the District would be around \$50,000. This cost would be recovered by the District in less than 2 years from energy savings.

Shari Hougan gave the AGR report (Achievement Gap Reduction). This information is required to be reported to the Board after each semester. The District sets goals in math and reading for grades 5K through 3rd. There is testing in the fall and then again in the spring to see if the goals have been achieved and where they need to improve. The District met some very high goals and look ahead to meeting even more.

Bryce Bird gave the Board the 2017-2018 Restraint and Seclusion report. He said the Riverdale School District does not use seclusion as a method of addressing student behavior. Restrain and Seclusion is utilized only as a safety procedure. Currently the District has 15 staff members trained and certified in nonviolent crisis intervention. The District had 2 incidents of restraint in 2017-18 and parents were notified on both occasions.

Students and Interviewers met at the end and when over what things to improve on.

Terry Ziebarth spoke to the Board on behalf of the Muscoda Mudcats baseball team. They wanted to thank the district for their corporation with the team. They will be donating \$250.00 to the district to show their appreciation.

Rebekah Gehrke, reported on the district report card for the 2016-17 school year. The district did very well with exceeding expectations in Elementary and High school and meeting expectations in the Middle school. She also told the board many factors go into this scoring and in a school the size of Riverdale a couple students can easily change the score.

This system would allow the school to be locked during school hours and visitors would need to be buzzed in. There is also a button that will lock down the whole school.
