Motion by Stitzer and second by Harris to approve the activity accounts as presented. Motion carried. Roll call vote. 9-0

Kelly Schaefer and Lynn Tarrell presented the AGR (Achievement Gap Reduction) Progress Update. They shared kindergarten through third grade targets and end results of the fall, winter, and spring data of reading and math.

Mr. Schmidt gave an update to the board regarding seeking a CESA 3 delegate. Nick Stitzer will do it. Mr. Schmidt reported that all of the first phase of the JH wing addition, bathroom remodel, and Ag room addition are going smoothly. They have been pouring the foundations of the additions and contractors are working on the demolition of the bathrooms. The variance for the Outdoor Learning Center was denied by Grant County. The Fund 50 balance is running high due the free meals offered. DPI requires us to spend the account down or come up with a plan.

Mrs. Hougan, Elementary Principal, informed the Board that the President's Award for Educational Excellence was given out to six fourth grade students, Allison Adams, Luke Campbell, Bryson Bohn, Allen Horton, Elizabeth Miess, and Rose Schramm. The award is given to students who have a GPA of 3.5 or higher and scored advanced in either Math or ELA on the WI Forward Exam. Sixty 5th and 6th grade students were recognized for achieving a 3.0 or higher GPA. The Riverdale Schools received a \$400.00 donation from Richland Area Retired Educators Association. 127 4K-6 grade students are signed up for the first session of summer school.

Mr. Campbell, Junior/Senior High School Principal, informed the Board that the Riverdale Track team sent 13 participants to state. Allyssa Husker earned 4th in the 200, Lauren Wiitanen placed 7th in the 100, Nick Stitzer placed 8th in the mile, the girls 4X200 relay team finished 8th, and the boys 4x200 placed 14th. Riverdale baseball lost to Pecatonica in the semifinal Division 4 sectional. 62% of high school student body and 57% of the junior high student body made the second semester honor rolls.

Mr. Schmidt gave an update to the board regarding Riverdale's Food Service team as being recognized as "Breakfast Hero's" during the National School Breakfast week by DPI. The food service team consists of Peggy Post, Mary Clark, Patty Behrens, Will Miller, Lynn Weeden, Kim Schroeder, and Terri Cooper. Mr. Schmidt discussed discontinuing student and athletic accident insurance. This costs the district \$11,000 per year and Riverdale is one of the few school in the area still offering insurance as a secondary option to cover costs that families primary insurance will not. Mr. Schmidt will bring this item up at the next school board meeting as an action item.

Mrs. Hougan, Elementary Principal, informed the Board that the 5th graders will take part in the six week CounterAct program facilitated by Police Chief Officer Schramm with Eric Nickolauson assisting. Riverdale will be sending a team of 4th and 5th grade students to the Lit Wars at SWTC on March 8th. Riverdale will be competing against 13 other CESA 3 schools.

Mr. Campbell, Junior/Senior High School Principal, informed the Board that Taylor Johnson is the Valedictorian and Leah Elliott is the Salutatorian of the Class of 2022. At the state powerlifting meet, Taylor Johnson placed 3rd, Carson Ramirez 6th, Blake Troxel and Jenna Wiitanen 15th, and Sabrina Line 17th. The competitors who qualified for the state wrestling tournament were Aston Miess, 3rd place, and Rylee Wanek. Students will take the Forward and Aspire tests April 5-7.

Mr. Schmidt gave a report on the upcoming CPI (Consumer Price Index) and some calendar options that are being discussed. This year's CPI is set at 4.7%. The past three years the CPI has been 1.2%, 1.8%, and 2.4%. Calendar options that were discussed were reducing student days from 180 to 178 and adding Martin Luther King Day and the Monday following Easter. We could add two additional paid holidays to the support staff contracts. We would have two built in snow days instead of four and possibly having early releases for students at 12:00pm instead of 1:00pm to give teaching staff more professional development time. These topics will be discussed next month.

Students and staff celebrated the 100th day of school on February 7th. Students in grades 3-8 will be taking the State Forward Exam. The testing window is March 21st-April 29th.

Mr. Campbell, Junior/Senior High School Principal, informed the Board that on Tuesday, January 18th the 7th graders went to the Heritage Center at the University of Dubuque to watch an acting group from Chicago present "Harriet Tubman". Juniors will be taking the ACT on Tuesday, March 8th. The other grade levels will be taking field trips that day. Six high school and three junior high students attended the SWAL Honors choir festival on January 29th at Darlington. On Saturday, February 5 eight FBLA students traveled to La Crosse Central HS for the Regional Leadership Conference. Riverdale finished 14th out of 37 schools. Four students qualified for the State Leadership Conference in Madison at the end of March. 66% of the high school and 57% of the junior high student body made the first semester honor roll.
